

Promotion Name: Big Greens Bucks Promotion

Promotional Period

1. "Big Greens. Bucks" Members Promotion ("Promotion") commences from Thursday 2 January 2025 and ends Thursday 18 December 2025 prior to the final draw at 7.00pm.

Entry Requirements

- 1. Entry is open to all financial members of the club.
- 2. Entry is by purchasing any food and/or beverage product from Revesby Greens.
- 3. Entry tickets will be automatically printed from the point-of-sale system.
- 4. A financial membership card must be swiped during point-of-sale transaction to activate promotion.
- 5. Entry tickets must be placed in the 'Big Greens Bucks' promotional for the chance to win. This barrel will close at 6.59pm, prior to the draw at 7pm.
- 6. All entries following the weekly draw will be void and emptied from the promotion barrel

Draws & Prizes

- 7. One (1) winner in total will be drawn each Thursday at 7.00pm during the promotional period
- 8. The minimum starting prize is a cash amount of \$100.00, this will jackpot every week by \$50.00 if the amount is unclaimed. (For example, the draw is for \$100.00 cash, if this is unclaimed then the following week the prize will be for \$150.00 and so on until the cap of \$1,000 if reached.)
- 9. Members must be present to claim a prize and will have four (4) minutes to do so.
- 10. **The jackpot feature is capped at \$1,000**. Once this amount is reached and the amount remains unclaimed at the 7pm draw, another draw at 7.05pm will commence, if unclaimed the process will be repeated in 5-minute intervals until 7.30pm
- 11. If a winner is still not found the \$1000 jackpot prize will be drawn the following Thursday.

<u>General</u>

- 2. No cash prizes can be awarded after 10pm.
